Dear Ms. Hajdu,

I hope you are well. I am a citizen of the Island of Montreal in the riding of Notre-Dame-de-Grace. Its elected Member of Parliament, the Honourable Marc Garneau, has asked me to contact you directly (see attached email).

We would like to participate in the Government of Canada's efforts to replenish its inventory of personal protective equipment to combat COVID-19. We offer to manufacture protective gowns and surgical masks manufactured entirely according to the standards required by Quebec. Attached to this email is a description of the manufacturing standards required for each of the items (Appendices 1 and 2). The production capacities are measured per million for each product and the factories are in Vietnam. We are fully proficient in the logistics chains for importing clothing to Canada from Vietnam since we have been in the retail business for 15 years. Deliveries are usually made by ship and we are currently exploring the use of aircraft.

We would like to build a strong partnership in support of the collective effort to care for our citizens while ensuring that employees have the proper health equipment. **If there are needs to be filled, we would be happy to participate in a discussion to offer you our services, clarifying quantities, deadlines and prices.**
