Good morning, Chelsea – at least I think that it is morning...I have been through so many time zones already that I am not even sure what my name is any more. And, on top of that, the scammers – today I received an email from one who co-opted the name of Hong Kong, but has an address in Shenzhen...and, wouldn't you know, he has "N95 masks readily available". I don't know how you keep your cool as I (here and at my China office) are 'only' getting a few dozen of these a day – you must be inundated.

To business – there are several things we can discussmy business in health products has been increasing exponentially as one person talks to/refers another and different requirements come to the fore as (some) other suppliers basically go as empty as their promises.

Summarizing, there are 3 types of personal 'regular' masks currently available — in no particular order:

- 1) N95 for medical use (and a sub-sector of N95 not NIOSH-rated) none can be reused with effectiveness
- 2) KN95 there are 74 Chinese factories that are FDA-approved and the KN95 masks from those factories have been accepted by the FDA (I forget the words but essentially for now due to shortages in availability of N95's) none can be reused with effectiveness
- 3) The mask that I exclusively represent which eliminates the virus on contact and can be washed at hospital temperatures for a minimum of 60 times, with total effectiveness

I can arrange supplies of any or all of the 3 (1 and 2 in adult and child sizes, as desired). I can also supply thermometers, visors, and gloves. Delivery from China, as you must know, is problematic – in the case of my suppliers, it isn't their delivery that is the problem (for me, at least), but the issue of government interference – I presume that you might have some input on that end. So, if you wish to discuss masks or any of the other products, just let me know – I assure you that I only deal with certified quality manufacturers...there will be no surprises (now, for you, won't that be a surprise LOL).
