Good Afternoon Matthew,

I've asked our dept to check on this, but considering your note on time sensitivity they've let me know they almost certainly won't be able to provide a response today. It will take a couple of days at least, and that being said there is no

certainty we will be able to confirm the numbers one way or another (in order to protect confidentiality of the Government's procurement/supply chain).

I would point you to the below links which provide some info on PPE procurement. However you will see the total value of Stansfield's contract is protected which makes me doubt we will be able to confirm full contract details for you. This is likely because the total number of units ordered is public, so we protect the total value of contract in order to prevent people from being able to reverse engineer the per unit cost. This is done to protect our procurement processes with regard to competitiveness.
