Although the product specifications for N95 masks exceed the retooling capabilities of our local manufacturers, They are looking at creating full face shields that masks can be affixed to. I know that this is not ideal. Would you be interested in the full face shields as a potential option to consider?

Rhonda, please see, below, our communication with the office of Our Honourable Member of Parliament. Our Home is in an active home-wide enteric outbreak situation (fourteen Residents), that requires droplet precautions. We have placed orders for surgical masks weekly for the past 4 weeks and 3 of these orders are on backorder. We received one case of supplies (12 boxes of 50 masks each) on Wednesday this week and it is almost gone.

We have reached out to several alternate suppliers (Shoppers Home Health, Cardinal Health and Medical Mart) with no success.

We have a pandemic supply of N95 masks that they we are not using as they will be a precious resource in the event of a COVID-19 outbreak (which has already occurred in a neighbouring Home), and are not appropriate for use with an enteric outbreak.

We will be in danger of running out of surgical masks by the start of next week. If you can, please help our Home as soon as possible.
