CONTEXT: This week's update to the *Supplying Canada's response to COVID-19* web page includes updated quantities ordered and received values for PPE supplies. The new numbers have been reviewed and approved by ADM Arianne Reza.
Program has provided the following notes regarding changes in orders:
N95 quantities ordered decreased by 1,363,580

- Jiangsu Hantang (PHAC) contract amendment decreased by 1,363,580
Gloves quantities ordered increased by 20,300,000 pairs
- Primed (PHAC) new contract increased by 20,300,000 pairs by March 31, 2021
