I've completed said form few days ago. I've also been in touch with Lambert, who works with Navdeep Bains, and provided him with a lot of information on masks, surgical masks, ventilators, testing kits, etc.

I have access to many if not all items that the government seems to be requesting.

Yet, we don't seem to be moving fast enough on procuring these items. I have not heard back on a timeline or even potential interest to move forward with any of the items I've advised are available.

I can understand decisions take time, and need to go through the appropriate channels. However, given the situation, couldn't matters be expedited?

Also, why make repeated announcements that panic the public that Canada is in dire need of certain supplies, when in fact such items are available and Canada just isn't moving fast enough to procure them?
