The most significant hold up is delays in getting the supplies delivered to the Shanghai International Airport from the manufacturers, some of whom are asking for payment. GAC is looking at options to help accelerate payment.

Another requirement is obtaining accelerated customs clearance (export permits) which normally takes 24-48 hours, after the goods are physically at the airport, to allow the goods to be loaded and the aircraft to take off.

Another issue involves securing landing permits in China and in Canada.

GAC and our missions in China including HOMs in BEJING and SHANGHAI are fully engaged to help resolve these issues.
