Hi Dove,

Nothing back from Health Canada, and as of yesterday the kit was FDA approved. This gives our supplier a much greater sense of urgency in terms of wanting to ship units to North America. A copy of the applicable approval certificate will follow.

Similar to the masks, we were able to secure allocation of inventory and production but we need to move quickly. We can commit to 100K units per week, but will need something back to make sure we get the shipments happening.

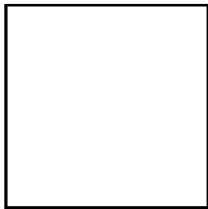
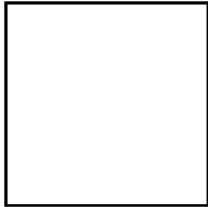
