- **Regulatory Consultants**

DuPont is looking into making hand sanitizer at our facility in Kingston, Ontario and we are looking for your help to get a Product License and a Site License for production of this material. We understand that Health Canada offered expedited licensing approvals this past weekend to manufactures of hand sanitizer but could use additional guidance on how we go about getting a license. Do you know who we can talk to within the Province of Ontario as well as Health Canada to move forward with this initiative?

We are estimating that we can produce around 2000 Liters per week, for the next few months. We are also looking for help to determine how to best distribute to groups in need (hospitals, test centers, long term healthcare facilities etc)

Any doors you can help us open at the provincial and national level would be greatly appreciated.
