Good afternoon,

Here's a debrief of our conversation with ISED. Please let me know if you have questions.

- PSPC will lead. ISED is available to support.
- ISED: ADM Charles Vincent would like to open the discussion by talking about the "Made in Canada project." They want this discussion to be a good news story, have a chance talk about their role and the successes.
- ISED: their only spokesperson will be Charles Vincent, but please note that ISED MO's press secretary, John Power, will be listening in on silent mode.
- ISED would prefer the interview to happen Thursday, Aug. 27, in the morning, if possible. They provided time slots. We are waiting on PSPC program to confirm time.
- ISED & PSPC are ok with the interview being on background with attributable quotes.
 However, both PSPC and ISED would like to raise the risk/possibility that the reporter takes any quotes he wants. To mitigate, PSPC will ask the reporter to attribute the quotes to PSPC officials or ISED officials.
