Hi Steven,

I just got off the phone with a lobbying firm trying to get this information to the federal government. The \$10k fee up front, has me trying to connect directly. I have a relationship with a company that produces the machines that make the masks. They are open to setting up a facility in Canada!!!! Anytime, if funds permit. They are validated on the CDC approved suppliers list. And there is NO broker in the middle. Just the government and the company.

I also wanted to let you know that I have negotiated in principle a contract to get 100,000 to 5million masks per month if needed.

NO RISK

Money does not leave Canada until the product is arrived and tested to your satisfaction.

All levels of government have just pushed me aside. I'm tired of hearing there is not enough. UHN is currently testing samples, Sunnybrook says they need to do their own testing.

Please see attached proposal. I have BDO accountant firm, Gowlings LLP, a customs company, and everything in place.

I'm just trying to get someone to look at it.
