Please see below email from Josh Cole, Business Development and a friend of Reena.

Working with the senior population in Ontario, as you can imagine, I have been getting daily requests from front line care workers, Long Term Care Homes, Retirement Homes, Group Homes, etc.. for PPE supplies which have been impossible to obtain due to the shortages. We have actually been able to source a significant supply of masks, gowns and goggles, in China however need assistance with expediting their import into Canada. We have quality control measures in place, including someone physically in China who has verified the certification and quality of the product, and will follow the product from the warehouse onto the trucks and onto the plane to ensure the integrity of the product remains intact. He continues to send us video footage of the inventory. With all of this in place, we can help alleviate some of the shortages, but we need your help in expediting the import process! Assisting us with bringing the product into Canada will be a huge win for the Ontario government and will help ensure the health and safety of our front line health care staff and vulnerable population.

They are also saying they have the capacity to produce 8M per day, so once we successfully open the supply chain, we can put a nice dent in the shortage for Ontario.

Please keep in mind that the longer it takes us to secure and ship the order, we run the risk of other countries scooping up our inventory in China so time is of essence.

Can you please ensure that the proper people responsible with sourcing material, see this email and know about this.

Reena and other developmental service agencies are short of all Personal Protection Equipment and this could make a HUGE difference for us and to keep our staff and individuals safe.
