I 6 Active Refusals to Work are being investigated by Transport Canada. All are from Flight Attendants at Air Canada refusing work due to PPE.

Agriculture:

Absenteeism is becoming increasingly prevalent throughout the processing sector. Agropur is reporting average absentee rates of 15% across its dairy facilities.

I Supplies of sanitation and PPE are running low amidst increased demand and enhanced safety measures, reports the Poultry Service Association. Absenteeism could worsen if workers perceive they are at risk from inadequate protection.
