In addition to leveraging existing sources of supply, Public Services and Procurement Canada (PSPC) is proactively engaging industry to help meet Canada's needs as part of our whole-of-government response to COVID-19.

PSPC has stood-up a dedicated team of procurement specialists who continue to assess responses as they come in, and is establishing a database of additional suppliers that may be used to help meet demands as we move forward.

Submissions received through this call to suppliers are assessed based on the requirements PSPC receives from the Public Health Agency of Canada (PHAC), and based on this assessment we will determine the most appropriate procurement approach.

There are no restrictions or preferences on suppliers. We are seeking input from any suppliers who have products and services available to help meet demands as we move forward.

As responses from suppliers are submitted to PSPC, we are working in collaboration with PHAC to ensure the necessary certification documents are in place while implementing flexible and innovative procurement approaches to best meet Canada's needs.

The Government of Canada continues to have regular communication with our partners at the provincial and territorial levels to assess and support procurement needs across the country. In leading this coordinated procurement approach for Canada, we stand ready to take further action to support the provinces and territories, our frontline health workers and Canadians.
