Please find below our mask offering with pricing as of May 15th, 2020. We currently have KN95, Non-Medical and Level I Medical Masks in-stock.

Also, as we continue to on-board our factories with the FDA and Health Canada, I am pleased to announce this week one of our main supplier, Fujian Leephick Pharmaceutical Industry CO. Ltd. is now listed on Health Canada's website for our Level 1 Medical Mask:

In addition, as many cities begin to open up, our demand has increased substantially and I wanted to share again which masks our industry partners are ordering:


- **Long-Term Care Facilities:** This continues to be the largest group we support in providing our Level I Medical mask and KN95.
- **Dental Practices:** As dental and related clinics are getting ready to open up, our KN95s are in high demand in combination with other PPE.
- **Medical & Pharmacy Clinics:** We are seeing increased orders in our Level I Medical masks to support doctor's offices, nursing and administrative staff.
- **Physiotherapy, Massage and Related:** Level I Medical masks are most common.
- **Restaurants & Hotels:** Non-Medical masks, but also Level I medical mask for those interacting with or preparing foods. For franchise partners in Canada and the USA, we have special programs we have arranged with certain restaurant chains
- **Manufacturing Facilities:** Many are ordering our Non-Medical masks, but for those manufacturing food, medicine, cannabis or related, our Level I Medical mask are purchased
- **Retail Stores:** Given our history in the shoe-business, most of our retail partner are large and small shoe retailer as many stores are now doing curbside pick up and getting ready to open to the public in limited capacity. Given it seems many

stores will require customers to wear face masks, retailers are preparing to provide customers non-medical masks for free

- **Construction and Related:** Non-Medical Masks and KN95s are most commonly purchased.
- **Service, Security & Property Management:** Non-Medical Masks are in high-demand.

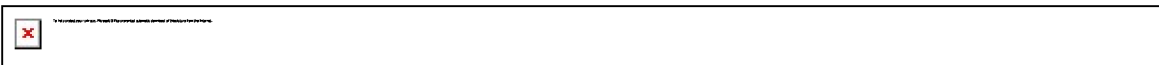

In China we have our own staff of 10+ men and women that are supporting our mask production currently. Work includes:

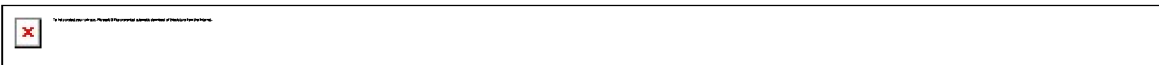
- Confirmation and Follow up of Orders
