#### 1. Masks:

- MDEL Done, we've received the registration approval letter. BYD Canada can import and sell masks.
- **Medical Device Interim Order** Submitted on 3/27, Health Canada is reviewing it, hopefully we will receive feedbacks tomorrow per phone call discussion with Jeffery Skene from Health Canada this afternoon 3/31.
- 2. <u>Hand Sanitizer</u> is not medical device in Canada, we've submitted MDEL, and was advised it would be handled and reviewed by a different group from Health Canada. We expect to get an update on Thursday 4/2.

I hope above information is helpful, and in the same time I believe the federal government of Canada and BYD have reached an agreement of supplying 50Million single-use surgical masks and 10Million Litre hand sanitizers.

BYD masks and hand sanitizer have both been approved by FDA, and today BYD Canada will submit the MDEL application to apply for Canadian approval.

In the same time I'm getting more concerned that, if we wait too long and couldn't act fast to submit the required quantity information to our factories, it will be more difficult to secure enough supplies for our communities in Canada.

The State of California, Washington, New York and Texas have been in very close contact with BYD US, and everyone wants to get ALL capacity we have for the next 2 months, and not to mention the governments in Europe have also been very proactively trying to secure supplies from China as well, BYD included.

Therefore, it is highly required that BYD Canada is able to collect future demand for next shipment as soon as possible, provided the extreme limited capacity that's available. The sooner we received the demand for masks & hand sanitizer, the quicker BYD Canada is able to allocate more supplies into Canada to support our communities.


