Hey!

Here's what we have on private clinics - apologies if the formatting is a bit off.

PRIVATE CLINICS

- This is **unacceptable**.
- We expect all jurisdictions to respect our public health system. We will not tolerate jurisdictions creating a two-tier healthcare system.
- We will always defend Canadians' access to healthcare – especially now.

If pressed:

- Patient charges undermine equity.** Charging someone for a test goes against the values of our universal healthcare system.
- All** Canadians deserve access to health care when they need it, regardless of their ability or willingness to pay.
- The emergence of clinics that offer paid, preferential access to COVID-19 testing is cause for concern. My department is monitoring these reports closely.

If pressed:

- Testing is one of the most important tools we have to respond to COVID-19.
- We are constantly working with the provinces and territories to increase laboratory capacity **and** the number of tests done per day.
- We are working with the provinces and territories on their testing strategies to ensure that Canadians can get tested when they need it.

FR

- Payer pour être traité plus vite est **inacceptable**.
- On s'attend à ce que les principes de santé publique soient respectés partout.
- On défendra toujours l'accès aux soins de santé publics, et il ne peut pas y avoir de système de santé à deux vitesses.

Si on insiste:

- Les frais facturés aux patients **nuisent à l'équité**. Faire payer un test à quelqu'un va à l'encontre des valeurs de notre système de santé.
- **Tous** les Canadiens méritent d'avoir accès aux soins de santé lorsqu'ils en ont besoin, quelle que soit leur capacité de payer.
- Santé Canada surveille la situation.

Si on insiste :

- Les tests sont l'un des outils les plus importants qu'on a pour faire face à la COVID-19.
- On travaille avec les provinces et les territoires pour augmenter leurs capacités à tester.

RESURGENCE – THANKSGIVING

- In these uncertain times, Canadians have responded to our calls for action, making changes to their ways of life so we can work **together** to stop the spread of COVID-19.
- We have made progress, **but** we know there is still work to do.
- As the weather gets colder, we need to keep practicing the things that have kept us safe – physical distancing, frequent hand washing, and avoiding large or crowded gatherings
- I know that it's hard to be away from your loved ones. But by staying apart, you are keeping each other safe.
