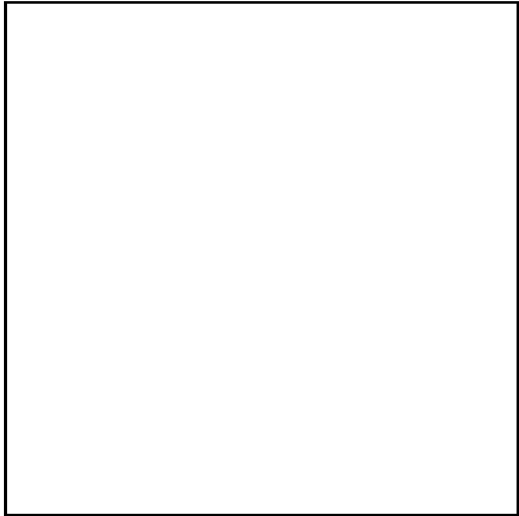
I have submitted on this site and did get a call from someone named Hanna but have had no contact for a few days and was confused why given the current crisis.

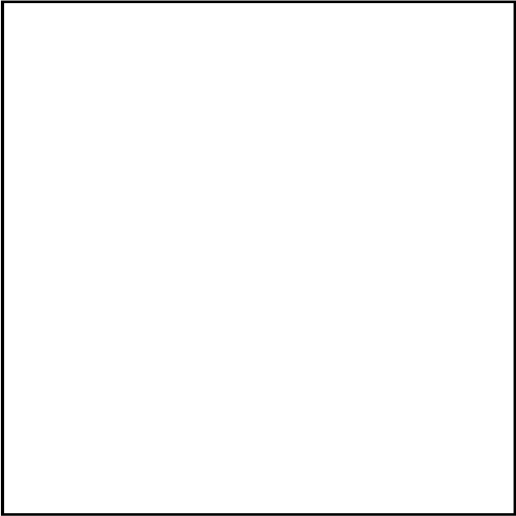
