**A1-2.** The Government of Canada awarded 15 contracts for 40,547 ventilators from 5 Canadian manufacturers (Thornhill, CAE, Canadian Emergency Ventilators, FTI Professional Grade Inc., and Vexos) and 8 international manufacturers. Domestic manufacturers will produce the majority of these ventilators. In order to protect our negotiating position and commercially sensitive pricing information, **we cannot disclose details, such as number of units per contract, that would allow one to calculate unit cost.**

As of October 13, Canada has received 3,210 ventilators from its various contract. All deliveries are expected by March 2021. Public Services and Procurement Canada continues to work with manufacturers to monitor delivery progress.

**CONTEXT (for your information):**

The reporter is working on a story about the government's ventilators procurement and would like some information.

**We also shared the following link with the reporter: <https://www.tpsgc-pwgsc.gc.ca/comm/aic-scr/contrats-contracts-eng.html#table-13>, but he still wants to know how many ventilators each company was contracted to provide, how many they have provided and when they are expected to fill the balance of the order.**

We tried to renegotiate, but the reporter is most likely filing tomorrow or Friday, at the latest. PSPC can provide a response for both questions, but we are also consulting PHAC/HC for input on Q2.

**QUESTIONS / RESPONSES:**

**Q1. Can you tell me which companies have the contracts and how many units each company is expected to deliver?**

**Q2. How many ventilators have been delivered from each firm and when are the bulk of**

**the deliveries expected? According to the government's PPE tracker just 725 of the more than 40,000 the government has ordered have been delivered.**
