Industry, Science and Economic Development Canada (ISED) has launched a “call to action” to Canadian manufacturers to help fight COVID-19. They have created a new web page as well as an intake for manufacturers that make needed supplies, have the potential to rapidly re-tool existing facilities or equipment, or who have skilled workers that could be available to work elsewhere in Canada.
