This is what I got back from my department on this:

Due to the COVID-19, TBS and other government departments have entered into their Business Continuity Plans or have reallocated their resources to support the Government's pandemic response effort. As this project requires large interdepartmental contributions and consultations, TBS temporarily paused progress on this initiative to allow departmental procurement and materiel management staff to focus on priority initiatives within their organizations. Once Business Continuity Plans are lifted, it is expected that interdepartmental work on this initiative will resume. While this may not necessarily result in an RFP being issued, that is certainly one among several options currently under consideration.
