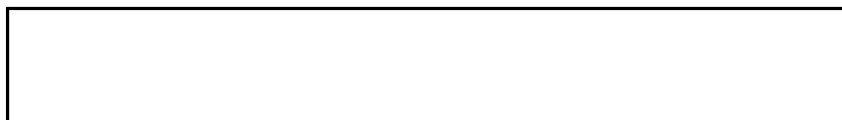

We haven't submitted our request on the buyandsell.ca page yet, as we are still working the the NHP licensing process. Currently we are waiting for a company code so that we can complete the application for HNP licensing. Should I submit a request to buyandsell.ca in the interim?

We are able to produce up to 10,000L per week, given the availability of ingredients. This would equate to 30,000 330ml units.
