There are currently several candidate vaccines in research and development, and it is not possible to determine which one(s) will be successful in preventing COVID-19 infection at this time. As such, the Government of Canada is supporting multiple organizations, which are working at unprecedented speed to develop candidate vaccines.

By supporting vaccine research and development, supporting biomanufacturing requirements for large-scale production, enhancing capacity and access for clinical trials, and seeking solutions for domestic capacity, Canada is in a better position to rapidly access a vaccine, once it becomes available.

The Government of Canada is closely monitoring vaccine development efforts, domestically and internationally, and will work quickly to negotiate advanced purchase agreements with vaccine manufacturer(s) to secure supply for Canadians as soon as it is feasible.
