Hi Manisha and Mary Jane,

Here's how things are looking in terms of the web links for the Notice on veterinary ventilators:

- The “**COVID-19 health product industry**” web page's **Ventilators** section (<https://www.canada.ca/en/health-canada/services/drugs-health-products/covid19-industry.html>) will be replaced with a landing page that will look like what's in the attached Word doc and there will be a blurb and link to the Notice on said landing page. Please let me know if you have any comments on the blurb wording regarding the Notice in the attached document (I think it's clear and looks good).
- There may also be a link to the Notice in the [health professional](#) topic page of the main COVID-19 site, under medical devices. This is still TBC by MDD and the web team.
- As for a link in VDD's Veterinary Drugs pages, we need to decide if this is needed or not. As discussed with Manisha this morning, we don't think this is necessary given that the pages are for veterinary drugs (leading to confusion?). However, if you feel that we need to add a link in our pages, I think it should go under What's New (<https://www.canada.ca/en/health-canada/services/drugs-health-products/veterinary-drugs/what-new-veterinary-drugs.html>) and contain a direct link to the Notice. In other words, there would be an entry for April 2020 and would list: ● **Notice: Repurposing veterinary ventilators for COVID-19 use in hospitals**. We will need to confirm this with MDD, as they are the ones working directly with web comms on this, by noon tomorrow (April 8).
