Thanks Travis. Will P/Ts be informed at the same time as MDEL holders?

Just want to make sure I understand this correctly. Is this accurate?

- There are 105 manufacturers in China that produce KN95s that may not provide proper respiratory protection
 - o The 105 manufacturers were identified via the FDA & via Canada's experience w Tango
- There are 63 MDEL holders who *may* have imported KN95s from these 105 manufacturers and who *may* have sent them to customers as medical respirators
- Tomorrow, the 63 MDEL holders will be asked to:
 - o immediately stop selling KN95s as respirators IF they have imported them from one or some of the 105 manufacturers
 - o relabel the KN95s as surgical masks or commercial masks IF their product is impacted
 - o issue a letter to their customers (i.e. hospitals) IF their product is impacted which says they can no longer be used as respirators and must be used as surgical masks or commercial masks
 - o send full recall plans to HC by EOD May 14 IF their product is impacted
- MDEL holders wishing to continue selling impacted product must apply for an authorization & must have independent lab performance testing accompanying their submission before they can proceed

And for sequencing, are you able to help fill in the blanks once you have more info?

- Tmrw: Letters sent to 63 MDEL holders
- TBC: Heads up to P/Ts
- TBC: Official recall notice on the Recalls & Safety Alerts database
- TBC: Public Advisory issued informing Canadians of this recall

> Hi friends,

>

> Want to advise you of action our Department is taking in response to the disappointing testing results we're seeing with the KN95s.

>

> As you know, earlier this week the U.S. FDA reduced the number of FDA-approved KN95s manufactured in China. We've run the revised list against our list of authorized devices under the Interim Order as well as have assessed Medical Device Establishment license numbers for implicated product.

> In sum, we have six N95s authorized for import under our Interim Order. Only one has been removed from the U.S. Authorization

List; this importer was advised yesterday to stop selling those particular devices as N95s. They may be sold for use as surgical masks (where the principle benefit is splash protection and is the standard we recommend for generalized healthcare settings outside intubation or other aerosol-generating procedures) or for non-medical use.

>

> Of our MDEL holders, 63 importers may be dealing with affected masks. As of May 5, we've approved 831 MDELs but they are not exclusive to importing N95s. Early this coming week, we will issue a letter to these MDEL holders advising of our stance on the import of KN95s not on the U.S. FDA approved list and asking them to provide more detail. They will be asked to label any affected product for use as surgical masks or for non-medical use. After we send the letters, we will have more detail on how many MDEL-holders were actually dealing with the poor-quality KN95s.

>

> It's important to note that provinces and territories generally are not deploying KN95s at this time for primary use in their systems; most are relying on N95s and stockpiling KN95s for use if the N95 supply runs dry. And of course, any masks procured through the collaborative FPT bulk buy will continue to be tested prior to distribution. Most PTs do not conduct independent tests on their masks; as I understand it, only BC and QC do.

>

> I will let PSPC jump in if necessary but early indications are that about half of our bulk buy is in N95s, with half in KN95s. I will stress that not all KN95s are unfit for use; this action is targeted at KN95 manufacturers consistently failing to meet testing standards. We will continue to allow KN95s that meet the standard for filtration. My understanding is that the vast majority of PSPC contracts for respirators are N95, not KN95, in any case.

>

> Moving forward, we will ask applicants under the IO to provide testing data for KN95s to validate the filtration standard, and we will not be publishing a broad-based list of "bad manufacturers" - just screening manufacturers more stringently. We will issue a public advisory on the matter once letters have been sent.

>

> Lines are in development and Ash (CC'd) can help you pinch hit if something comes up urgently.
