Le gouvernement du Canada consacre environ 6 milliards de dollars à l'achat d'équipement de protection individuelle (ÉPI), d'équipement médical et de fournitures pour assurer la sécurité des Canadiens. Ce montant comprend 4,5 milliards de dollars accordés au Cadre de relance sécuritaire. [The Government of Canada is dedicating approximately \$6-billion to buying personal protective equipment, medical equipment and supplies to keep Canadians safe. This includes \$4.5-billion as part of the Safe Restart Agreement.]

Nous avons adopté une stratégie d'achat agressive, et nous diversifions nos chaînes d'approvisionnement afin de répondre aux demandes immédiates d'ÉPI et de nous préparer aux besoins futurs, notamment une éventuelle deuxième vague. Cette stratégie produit des résultats pour les Canadiens en permettant de sécuriser des approvisionnements nécessaires et de mobiliser l'industrie canadienne. [We have pursued an aggressive procurement strategy and are diversifying our supply chains in order to meet immediate demands for PPE as well as to prepare for future needs, including a potential second wave. This strategy is delivering results for Canadians in terms of securing much needed supplies and also engaging Canadian industry.]

À ce jour, le Canada a conclu des contrats totalisant environ 6 milliards de dollars au nom de l'Agence de la santé publique du Canada pour fournir des ÉPI aux provinces et territoires, aux ministères et organismes fédéraux et à la Réserve d'urgence pour les services essentiels. Plus de 80 % de la valeur totale de ces accords a été accordée à des entreprises canadiennes fournissant ou distribuant des ÉPI. Des contrats totalisant près de 2,5 milliards de dollars ont été conclus avec des fabricants canadiens, dont beaucoup ont été identifiés grâce à des appels d'offres lancés par Services publics et Approvisionnement Canada (SPAC) et Innovation, Sciences et Développement économique Canada.
