As you know Fabrene, Inc. (a subsidiary of Berry Global) has been making woven materials in North Bay for over 50 years. During the Covid-19 crisis, our facility has re-directed some assets to produce medical gown fabrics for front line workers in both Canada and US. Our company is now working with Medicom, a leading manufacturer of medical masks, to install new equipment in North Bay to support mask making capabilities in Canada. It appears Medicom is in discussions with the Canadian Government to secure a supply chain agreement. The investment for our site is in excess of \$10M, with the potential to hire another 20 people. Medicom is taking the lead on this initiative and Fabrene is not trying in intercede, however, we would truly like to know if the Canadian Government is seriously considering this type of project or if it is only a pipe dream.
