Here is an excerpt from what Minister said this Tuesday:

For example, in this regard, we've received 13.8 million face shields, almost half of which were made right here in Canada. We've now received more than 6.6 million litres of hand sanitizer, primarily from Canadian manufacturers. And we've also received over 100 million masks, 34 million pairs of gloves and almost 4 million gowns.

In addition, approximately 160 ventilators have been delivered and are being inventoried by the Public Health Agency of Canada. Finally, we have distributed more than 2.7 million N95 respirators to the provinces and territories.

Hello—For the critics update, what does everyone think about using the following:

- Increases from last week based on current version of web table;
- Totals from current version of web table;
- Distribution numbers from PHAC. The rationale here is to present a new metric to distract somewhat from unattractive delivery numbers being reported. Hajdu goes into QP with these numbers, updated weekly, so we're in safe territory:
  - o The Public Health Agency of Canada is receiving staggered delivery of shipments, and to date, has allocated approximately 2.5 million N95 respirators and equivalents (e.g., KN95 respirators; FFP2), 100 million surgical masks, 26.5 million pairs of nitrile gloves, 12 million face shields, and 2 million protective gowns to provinces and territories, and more is expected to arrive and be distributed in the coming days.
