Here's a draft set for the ON procurement and retooling initiative:

- ~~- This initiative complements work underway at the federal level.~~
- The federal stockpile contains supplies that provinces and territories can request when their own resources are not enough.
- Collaborative bulk purchases with the provinces, and by the federal government are underway on a range of essential goods.
- The Public Health Agency of Canada is working closely with federal partners, provinces and territories to assess needs, and identify priority items.

If-pressed:

- The NESS is supplementary to the supply of essential goods held by the provinces and territories.
- We will continue securing additional supplies to ensure they are available for provinces, territories, frontline health workers and Canadians when needed.

(Re-tooling)

- ISED is leading on engaging Canadian industry partners to deliver breakthrough solutions, re-tool and scale up to meet critical needs, while my department is leveraging existing sources of supply and proactively engaging suppliers who may be able to provide products and services to meet current and future needs.
- We are implementing flexible and innovative procurement approaches to accelerate Canada's response to the pandemic.
- Across government, we will continue working closely with partners at all levels of government, and with industry, to ensure Canadians and their families are safe.
