Ms. France Bélanger forwarded me your contact information so that we could send you our propositions for the manufacture of protective products.

As a result of the developments of the last few days, we were forced to temporarily close our facilities. I am therefore sending you this email to offer our services for all sewing needs. We can also subcontract with companies that are already in production.

We have been in the bedding and sleepwear business for more than 30 years. Approximately 30 people are employed by the company in production and shipping. We have vast experience and skills in garment manufacturing.

We are also fabric importers. We have a large inventory of fabrics, such as poly cotton, 100% cotton, various quilted fabrics for mattress pads, water-repellant fabrics for protecting mattresses, fabrics for fleece blankets, non-woven polypropylene, pillows, and so forth.

Over the next week, we are also expecting fabrics certified for manufacturing protective masks. We are in the process of assembling a prototype in order to be able to manufacture this equipment. We are able to invest in protection equipment to be able to mass produce in the coming months and years. Our first mask prototype is attached to this email.

We would be very pleased to do our part to help the health field, in our own way. A team could be established for manufacturing items that need to be sewn, regardless of the need.
