James and I are trying to track down a few additional pieces for tomorrow's presser.

- 1. Our understanding is that the Provinces are receiving direct shipments of N95 masks from 3M in the US each month at a total of 500K across the board. Does this arrangement involve the federal government in any way, and if not are we able to confirm if this allotment is still being providing directly to PTs / which jurisdictions are receiving it? Understanding that this falls under HC.
- 2. With the total count for face shields now at approx. 4.8M can we confirm what portion of this has been received from domestic manufacturers & if at all possible if that includes manufacturers beyond Toronto Stamp and Bauer?
- 3. How many gowns have been received from domestic manufacturers? I know mid last week we were at 100K.

Happy to get whatever we can dig up on this today for the presser tomorrow - even if it needs to come in piece meal that is more than welcome.

We are now on for Tuesday news conference. Minister likely to do it either from Oakville or Toronto.

Her speaking notes are now with my MINO colleagues for input.

One question I have that I'm hoping we can nail down before Tuesday is about hand sanitizer. We already confirmed that the drop in the orders number (from 80-million to 20-million) is entirely due to the conversion of units to litres.

Is there a way to figure out what the net change in amount received is?

Last week, we had about 71k units - now we have 87k litres.

How much of that is due to the conversion and how much is newly received in the past week?
