France Belanger gave me your contact information so that we could let you know that we are able to manufacture personal protective equipment.

Due to recent developments, we have had to temporarily halt our regular activities.

I am therefore sending you this email to offer you our sewing services. We can also subcontract with companies that are already in production mode.

We have been manufacturing bedding and sleepwear for over 30 years. We have approximately 30 employees working in manufacturing and shipping. We have a great deal of experience and skill in the sewing industry.

We also import fabric. We have a large inventory of fabric, such as poly-cotton, 100% cotton, quilted textile products for mattress covers, waterproof fabrics for mattress protection, fleece fabric for blankets, non-woven polypropylene fabric, pillows, etc.

We are also expecting a shipment of fabric that is certified for the production of protective masks next week. We are developing a prototype to be able to produce this equipment. We are able to invest in the equipment necessary for high-volume production in the coming months and years. Please find attached information on our first mask prototype.

We would be pleased to do our part and contribute in our own way to public health. We can set up a team to manufacture items that require sewing no matter what the requirements are.
