Dear Mr. Paul Lefebvre,

I am writing to you regarding my concern about the lack of communication about my offer of a hand sanitizer product, which we have been producing for the past week.

We have all the accreditations in hand and I took the liberty of attaching them to the e-mail. We have our NPN (Product licence) and SL (Site licence), our user licence from Revenue Canada, as well as our Y15 for Customs.

We have established a partnership with PEPCO, a local company, with the distillery. They have the logistics, the transport equipment for ethanol, and the space to accommodate production. We have the expertise and the licences. A nice combination.

We started shipping our product yesterday to our first U.S. customer, a 1-gallon truck trip with 24 pallets. Our contact for the USA is Hon. Paul Bonwick P.C., Senior Vice President, Clearview Aviation Business Park Inc, Stonebrook Developments Inc.

We also have a sales contract with the province of Ontario for twenty 1,000-litre containers, with 2,000 5-gallons leaving our site tomorrow. Another order of 3,000 5-gallons next week with them again. It's for the OPP and the penitentiaries.

We also have a 180,000 litres per week contract in Quebec for six months with a buyer who redistributes in the Quebec government. They want to increase their purchases and have to come back to us at the end of the week to tell us what they need.

We have secured all our inputs, 300,000 litres of ethanol per day. Glycerol and aloe are not a problem either.

I am disappointed by the following: Last week, I submitted our product offering to the Canadian government and immediately received an evening call from Elias Bardouviotis (P [REDACTED]). He told me that the government would be very interested in picking up our product, that he thought it was excellent. He told me he "flagged" the application to forward it to the next person in command.

I got a call from Alexis Wagner (P [REDACTED]). She asked me for all my information, which I forwarded to her. All I needed was our NPN, and I explained to her that Health Canada was very busy with all the requests and that I would be receiving it shortly. I would surely have some minor changes to make and then everything would be fine. I received confirmation that we would receive our NPN on Monday morning. I sent our NPN to Alexis, talked to her on Tuesday, and then nothing. She told me that she would "flag" the product at the next step, but that the government might already have hand sanitizer covered.

What I do not understand is that I continue to get calls from Aboriginal reserves, like the one in Thunder Bay, that have cases, and there is no hand sanitizer.

On several occasions I tried to contact Ms. Alexis without success. Aime Demateo from FEDNOR tells me that this is not really normal, that the government should support us throughout the process, especially when we have product and can help stop this virus.

I hope you will be able to help me, and thank you for listening to me this afternoon.
